All sales are FINAL. Buyer will go over all animals purchased before they leave the farm or expo. Animals are free of disease and medical defect to the best of our knowledge at the time of purchase.

The animal(s) listed on page one of this agreement are sold as PETS ONLY. This means:

- 1. Animal has been sold by seller as a pet only animal. Pet only animals shall be understood to mean that because of disqualifying cosmetic faults as defined in the standard for that species, which appears to be irreversible, the animal shall not be bred.
- 2. Buyer agrees to take all measures necessary to insure the animal purchased is NOT MATED and does not have the opportunity to sire or deliver a litter or litters. IF any animals purchased from us sire/deliver a litter, Cherokee Flats reserves the right to take back said animal(s) and any offspring. For this reason, we will not sell multiple rabbits to pet only homes without a signed Risk Acknowledgment Agreement and will ONLY sell same sex pairs of Rats or Mice.

General Guarantee

- 1. The buyer is completely satisfied and waives any and all claims regarding the animal(s) confirmation and outward appearance.
- 2. This agreement is made and signed by both parties to ensure the well being and protection of all parties involved. If any part of the agreement is breached, the seller is released from any further obligation here under.
